- 5. Shri Jaipal Singh and Shri M.D.Sharma be expelled from the Joint General Secretary and Assistant General Secretary for their anti Union activities, irresponsible behaviour as Central Office Bearers.
- 6. Northern Region RED Office Two branch will remain operative No. One RED office Branch, Second IGI Airport Branch. Employees working in the respective units will be the member of that particular Branch.
- 7. Branch Account I.G.I Branch shall be operated as per conventional practice of A.A.E.U. Branch Treasurer R.K. Avasthi and Branch Secretary Shri Vinod shall operate the account. General Secretary will communicate to the Bank.
- 8. As per provisions Trade Union Act Union can operate bank account with scheduled bank only. Fund kept at IAAI Staff Theft and Credit Society Reg.No. 456U Delhi to be withdrawn immediately and deposit to schedule bank.
- All Organizational matters shall be dealt by CHQ i.e.(Disciplinary action, All branch Elections, CEC/COB election in between AIC) will be administered as per organizational guide line.
- 10. Shri. Satish Kumar Sharma will be the third signatory as per provision of constitution to operate the CHQ Account with immediate effect.
