#### Subject : Incentive scheme on acquiring professional/additional qualifications. Ref. A 60011/54/2009/HRPC/424 dated 23<sup>rd</sup> Dec 2020.

Sir.

Reference is made to CHQ circular No.46/2019, dated 01/08/2019 regarding admissibility of increment (s) to all the officials for acquiring professional/additional qualification on or before 25/03/2010. It may be mentioned that, as per CHQ Circular No. A60011/61/98-PP dt. 19.08.1998, grant of additional increment(s) for acquiring higher study was implemented. Later on, vide CHQs circular No. A60011/69/2009-PP (09/2020) dt. 25.03.2010, the incentive scheme for grant of one and /or two increments was withdrawn w.e.f. 01.01.2007. Thereafter, considering Hon'ble High Court of Kerala Judgement in respect of WP (C) No. 22395/2010, CHQ issued a further circular vide No. 46/2019, dated 01/08/2019, to this effect that the officials will be allowed for increment(s) for acquiring higher study who had completed and got result within 25.03.2010 instead of 01.01.2007. But unfortunately, the officials who were permitted to acquire higher studies on or before 25.03.2010, but did not get the result of course within the stipulated date, are deprived of getting increments which was likely to be paid as per the then regulation.

In view of the above, it is submitted that those employees who have got prior permission on or before 25.03.2010 and enrolled themselves for study and accordingly acquired the certificate, may be allowed to get the increment as per eligibility.
