**Subject : Conduct of mandatory Training course in Fire Discipline – reg.**

Sir,

You would appreciate that, due to unprecedented event of Covid – 19 outbreak the physical training in respect of fire discipline scheduled for the year 2020-21 & 21-22 have been put on hold leading to backlog of fire training at various levels.

In wake of the pandemic situation, the mandatory fire courses have been conducted virtually viz., 81<sup>st</sup> & 82<sup>nd</sup> batch of ARC-1 and 66<sup>th</sup> batch of JFO course commenced from 01.02.2021 to 16.04.201 & 01.02.2021 to 05 03.21 and thereafter no course has been scheduled till date for the above level.

The above said courses are being mandatory for promotion to the next level. Delay in completion of the courses would ultimately affect the promotional avenue of the non-executives.

There are many non-executives in fire discipline who have completed the eligibility service for promotion to the next level and are due for promotion in the ensuing DPC period 2022 have not completed the above said courses on the pretext of non-conduct of training by the Management.

Keeping in view of the backlog of various training courses and as chances for completing the said training courses before the forthcoming DPC period are very remote, it is requested that CHQ may kindly take the appropriate


