In continuation to this office letter of even no. dated 7.7.2023 vide which instructions/modalities for holding secret ballot election in the establishment of Airports Authority of India were issued, the name of union inadvertently mentioned as Airport Authority Kamgar Union at page 1 5<sup>th</sup> para 4th line may be read as 'Indian Airports Kamgar Union'.

# QUALIFICATION OF VOTERS

Only regular workman who are on the muster roll of Airports Authority of India as on 1.8.2023 at the level of NE-1 to NE-10 and non executive/workmen holding the scale of Rs 20600-46500 (pre revised) in the grade of E-2, or granted scale of E 3 or E 4 under SRS (but not granted executive designation) and Assistant Manager under FCS are eligible to vote. The voter list shall be published by the management on or before 14.07.2023. The objections/corrections if any may be submitted to the management by the unions/individual till 1700 hrs on 21.07.2023. The final Voters List shall be published latest by 02.08.2023.

#### VOTING IN ELECTION

- a. A workman shall cast his vote by marking the rubber stamp (cross sign) meant for the purpose in the column against the name of the union secretly on the ballot paper duly issued to him by the Presiding Officer. If the mark of the stamp crosses the line between the columns of two unions and the intention of the voter is not clear, the vote shall be declared invalid.
- b. If a workman cast more than one votes, the ballot paper shall be declared invalid.
- The ballot paper without the signature of Presiding/Polling officer shall be declared invalid.
- d. Every workman is required to show his/her valid Photo Identity Card at the time of casting his/her vote,

#### POSTAL BALLOT

All the postal ballot papers shall be signed by the Assistant Returning Officer at New Delhi and the management of AAI shall distribute the same to the respective RHQ of AAI in sealed cover.

#### APPOINTMENT OF PRESIDING /POLLING OFFICER

The Management of AAI shall appoint the competent officers as presiding/polling officers for each booth and publish the list of such officers with the prior approval by the Returning Officer latest by 2.8.2023. These officers shall be responsible for conducting the election according to the instructions given by the RO/ARO.

## COUNTING OF VOTES

The counting of votes shall start at 2030 hrs on 28.08.2023 in the Polling/Counting Booths under the supervision of ARO in the presence of authorized agents of the participating unions. A union may authorize only one agent from amongst the voter list published by the management to be present in counting. The presiding/polling officers shall be responsible for counting of votes. The counting officer will show sealed ballot boxes to the candidates/agents before opening the box and he will also explain the mode and procedure for counting of votes. He will sign the Counting sheet and obtain signatures of candidates/agents after recording the total number of votes received by each union and submit to the RO.

#### BALLOT BOXES

Adequate number of ballot boxes with its lock and key(with sealing material) will be provided at each polling station by the management.

### DECLARATION OF RESULT

The RO shall declare the result of the secret ballot after the counting of votes is over. However the final result shall be declared on 05.09.2023 after counting of postal ballot papers.

# SECURITY ARRANGEMENTS ON ELECTION DAY

The Management of AAI shall ensure adequate security arrangements during the election to maintain law and order in the establishment.

#### SPECIAL INSTRUCTIONS FOR UNIONS

- The names of the unions shall be in English alphabetical order in the ballot in Hindi, English and one regional language.
- The union will give the name of his agent in writing to the management latest by 17.08.2023.
- The unions and their agents shall be responsible for maintaining an orderly and disciplined behavior.
- 4. Defacing of the building walls by sticking posters, placards etc is not allowed.
- Unions and their supporters will maintain peace and discipline both inside the establishment.
- 6. Canvassing shall not be allowed 24 hours before the actual date and time of polling.
- 7. Mobile & Cameras are not allowed during the Polling and Counting.


# आचार संहिता

- बी. एएआई कर्मचारी (आचरण, अनुशासन और अपील) विनियम, 2003 के प्रावधानों और इन तौर-तरीकों सिहत चुनाव अधिकारी द्वारा जारी संबंधित निर्देशों का पालन करने के अलावा, सभी चुनाव लड़ने वाली यूनियने चुनाव प्रक्रिया के दौरान "आचार संहिता" के प्रावधानों का पालन करेंगी।

- एफ. असत्यापित बयानों के आधार पर अन्य यूनियनों या उसके पदाधिकारियों या उनके कार्यकर्ताओं की आलोचना नहीं की जाएगी।
- जी. ऐसे निर्वाचित जन प्रतिनिधियों द्वारा प्रचार करने की अनुमित नहीं है जो किसी भी प्रतिस्पर्धी यूनियन या राष्ट्रीय संघ में पद्धारित नहीं हैं।
- एच. मतदान केंद्रों के 100 मीटर के भीतर चुनाव प्रचार और मतदान की वास्तविक तिथि और समय से 24 घंटे पहले सार्वजनिक बैठकें आयोजित करने की अनुमति नहीं दी जाएगी।

The final Voters List shall be published latest by 02.08.2023.

#### VOTING IN ELECTION

- a. A workman shall cast his vote by marking the rubber stamp (cross sign) meant for the purpose in the column against the name of the union secretly on the ballot paper duly issued to him by the Presiding Officer. If the mark of the stamp crosses the line between the columns of two unions and the intention of the voter is not clear, the vote shall be declared invalid.
- b. If a workman cast more than one votes, the ballot paper shall be declared invalid.
- c. The ballot paper without the signature of Presiding/Polling officer shall be declared invalid
- d. Every workman is required to show his/her valid Photo Identity Card at the time of casting his/her vote.

# POSTAL BALLOT

All the postal ballot papers shall be signed by the Assistant Returning Officer at New Delhi and the management of AAI shall distribute the same to the respective RHQ of AAI in sealed cover.

#### APPOINTMENT OF PRESIDING /POLLING OFFICER

The Management of AAI shall appoint the competent officers as presiding/polling officers for each booth and publish the list of such officers with the prior approval by the Returning Officer latest by 2.8.2023. These officers shall be responsible for conducting the election according to the instructions given by the RO/ARO.

## COUNTING OF VOTES

The counting of votes shall start at 2030 hrs on 28.08.2023 in the Polling/Counting Booths under the supervision of ARO in the presence of authorized agents of the participating unions. A union may authorize only one agent from amongst the voter list published by the management to be present in counting. The presiding/polling officers shall be responsible for counting of votes. The counting officer will show sealed ballot boxes to the candidates/agents before opening the box and he will also explain the mode and procedure for counting of votes. He will sign the Counting sheet and obtain signatures of candidates/agents after recording the total number of votes received by each union and submit to the RO.

### **ELECTION SCHEDULE**

#### BALLOT BOXES

Adequate number of ballot boxes with its lock and key(with sealing material) will be provided at each polling station by the management.

# **DECLARATION OF RESULT**

The RO shall declare the result of the secret ballot after the counting of votes is over. However the final result shall be declared on 05.09.2023 after counting of postal ballot papers.

# SECURITY ARRANGEMENTS ON ELECTION DAY

The Management of AAI shall ensure adequate security arrangements during the election to maintain law and order in the establishment.

## SPECIAL INSTRUCTIONS FOR UNIONS

- 1. The names of the unions shall be in English alphabetical order in the ballot in Hindi, English and one regional language.
- 2. The union will give the name of his agent in writing to the management latest by 17.08.2023.
- 3. The unions and their agents shall be responsible for maintaining an orderly and disciplined behavior.
- 4. Defacing of the building walls by sticking posters, placards etc is not allowed.
- 5. Unions and their supporters will maintain peace and discipline both inside the establishment.
- 6. Canvassing shall not be allowed 24 hours before the actual date and time of polling.

7. Mobile & Cameras are not allowed during the Polling and Counting.

# TRADE UNIONS REFERENDUM -2023

## CODE OF CONDUCT

- a. "Code of Conduct" comes into force from the date of declaration of election i.e., 30.06.2023, as notified by the Deputy Chief Labour Commissioner (Central) -cum- Returning Officer, New Delhi vide letter No. ND.11(01)/2023-VFN. dated 07.07.2023.
- b. Apart from adhering to provisions of AAI Employees (Conduct, Discipline and Appeal) Regulations, 2003 and related instructions issued by Returning Officer including these modalities, all contesting unions shall obey the provisions of "Code of Conduct" during the course of the election process.
- c. Any contesting union shall NOT make any appeal to voters on grounds of religion, politics, caste, community, region and language etc.
- d. Any contesting union or its office bearers/representatives shall NOT indulge in any activity which may cause tension/rift amongst different categories, cadres, communities, religions etc.
- e. Criticism of rival unions should be confined to their policies, programmes and past records of work. Private life of individual/office bearers and activities not connected with the functioning of AAI shall NOT be raised during canvassing.
- f. Criticism of other unions or its office bearers or their workers based on unverified statements shall not be made.
- g. Campaigning by elected public representatives who are not holding post in any of the contesting unions or National Federations is not permitted.
- h. Electioneering within 100 meters of polling booths and holding public meetings shall NOT be allowed 24 hours before the actual date and time of polling.
- i. Intimidation of any type, threatening, coercing or forcing any AAI workmen to vote in a particular manner is not permitted.
- j. Possession of fire-arms, arms, slogan shouting, inciting communal / political / religious passions is NOT permitted.
- k. Contesting unions are NOT permitted to hold any meetings during working hours.
- 1. Contesting unions may convene gate meetings (restricted to maximum of two meetings only at same venue / office / airport) during lunch hours with prior permission of the Officer-in-Charge. No gate meeting shall be allowed within 24 hours of election. In case, intimation is received from more than one contesting unions for holding meeting on any particular day/time, the decision of the Officer-in-Charge shall be final and binding.

- m. Distribution of gifts / cash / kind is strictly prohibited.
- n. The contesting unions shall NOT deface the buildings / office premises by placing banners, posters, placards, pasting stickers including writing on the walls/glass of office and other buildings in colonies, etc. The contesting unions shall strictly follow the instructions issued vide letter No. B-20019/1/2022-HRM-Part (1)/369-389 dated 14.07.2023 in this regard. The Administration would provide/designate appropriate space for pasting of posters/campaigning material to the contesting unions. Any poster placed other than the provided / designated space shall attract violation of Code of Conduct and the Administration has the right to remove the same without any intimation to the contesting union. After completion of the elections, the contesting unions shall remove their posters, etc.
- o. No disrespect shall be shown to pictures of present and past national leaders, union representatives, AAI Officers, etc. in the posters during canvassing
- p. All authorized Polling agents of the contesting unions shall be in possession of valid identification cards (issued by the Presiding Officer) while entering polling booth area.
- q. Except the voters, individuals without a valid pass issued by the Presiding Officer shall NOT be allowed to enter the polling booth.
- r. No special leave, tour etc. for campaigning/canvassing shall be allowed to any AAI employees or representatives of unions.
- s. Any other activity during electioneering which is extraneous, repugnant, contrary to the recognized sphere of union activities, against tranquillity and public peace shall be prohibited.
- t. No executive is allowed to participate in the canvassing / polling / counting from the Union side, as otherwise such executives shall be liable for action in accordance with the AAI Employees (Conduct, Discipline and Appeal) Regulations, 2003.
- u. Use of mobile phones, cameras, video cameras, tablets, notebooks, or any other electronic gadgets by voters, Polling Agents and representatives of unions is strictly prohibited inside the polling booth as well as the counting hall/room. Such items are not allowed inside the Polling Booth even in switched-off mode.
- v. Use of loudspeakers / playing Dhol, etc. in office premises, terminal buildings, passenger areas and other sensitive areas is strictly prohibited.
